Summary of fund objective

The Funds objective is to provide total return with low to moderate correlations relative to traditional financial market indices, by gaining exposure to three asset classes: debt securities, equities, and commodities. The overall risk of the Fund is intended to be consistent with that of a balanced portfolio of equity and debt securities. Derivative instrument positions will not exceed 300%. 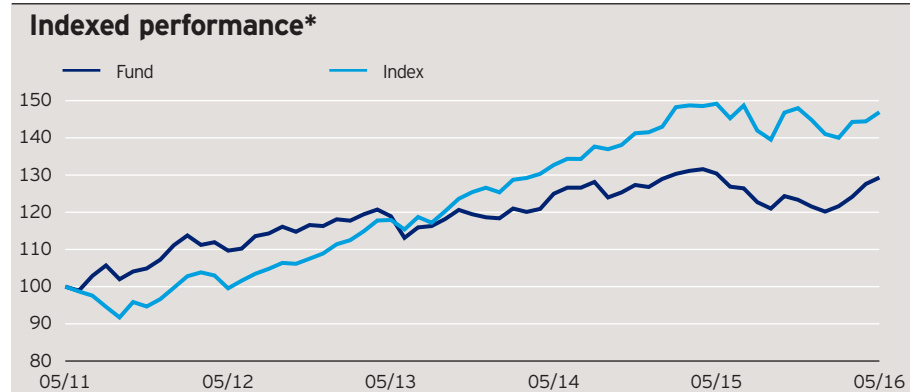

Quarterly fund commentary

The first quarter of 2016 saw the return of the volatility in global equities following the first interest rate hike by the US Federal Reserve since the advent of the financial crisis. This environment let the government bond markets emerge as the clear winner for the period. Its strong performance over the first two months due to perceived 'safe haven' flows saw only minor dilution in March, when 'risk on' assets proved to be more in demand. During that final month of the quarter, global equity markets woke up to stage a rally after a less than stellar start to the year. Whilst this rally proved beneficial for the fund, this boost was not enough to negate the effects equity market volatility had over the prior two months. The commodity markets in aggregate were provided some respite from the freefall in prices. This was largely due to strength in metal prices early in the quarter and strength in agricultural and energy commodities later on. Moving into the next quarter, the fund now has an overweight exposure (relative to the fund's strategic positioning) to all six equity markets it offers exposure to, while the overweight exposure to bonds has softened. Within commodities, the fund now has a neutral or overweight exposure to most assets included in the fund.

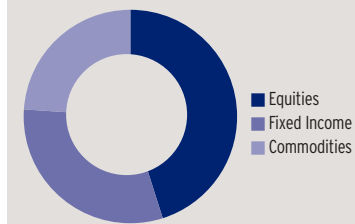
