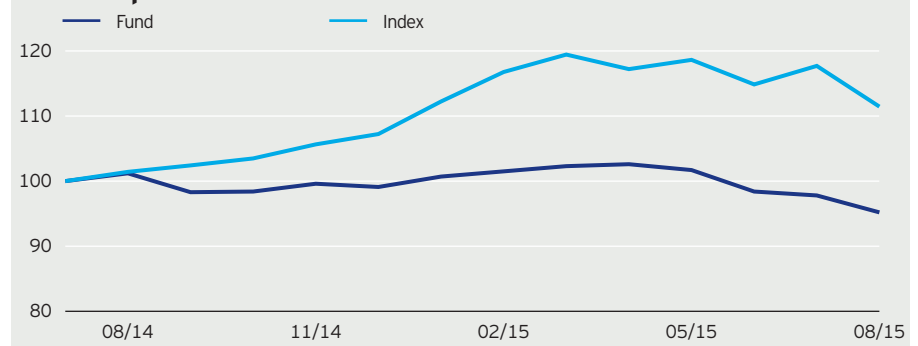

Quarterly fund commentary

The second quarter of 2015 played host to several events that impacted the financial markets. Chief amongst them was the escalation of the Greek financial crisis, and the unsuccessful attempts of the country's government to negotiate with its creditors. In China, equity markets declined following the sharp rise of its local equity markets over the past year. Weaker than expected economic data across key markets and the expected interest rate hike by the US Federal Reserve (Fed) further added to the heightened volatility seen across all three asset classes the fund is exposed to. In this market environment, global equity markets surrendered much of their early period gains. Bond markets generally declined in anticipation of the Fed's plan of raising interest rates later this year, as well as the receding deflationary fears in Europe. Commodity markets produced mixed returns. The energy sector was able to hold on to gains from earlier in the quarter. However, metals were weak on concerns that a slowing economy would negatively impact demand.

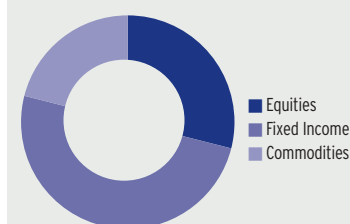
